1) Place and date

2) Jamboree theme: A hundred years of adventure

In the National Jamboree, you will have the opportunity to expand your dreams and see a universe full of possibilities and inspiring projects. There's no limit to what you can reach. Be ready to meet scouts from all over the country, share unique experiences, and make friends for the rest of your life.

Be ready for incredible challenges like thrilling trails, games, and moments of joy. It will be an unforgettable experience, full of surprises and discoveries. Join us at the National Scout Jamboree and leave your mark on the history of Scouts in Brazil.

3) Educational program



The educational proposal of the "Century Jamboree" is based on the basic concepts of the Educational Project of the Scouts of Brazil, seeking to stimulate in young people the ability to play, dream, venture out, create, and reflect, as privileged means for them to discover their own identity, learning to live with other people, exploring the world and transforming realities. In the year in which we celebrate our centenary, we invite scouts to reflect, freely and responsibly, on how the Scout values are being lived in their lives and on how these can help build a more just and fraternal society.

We intend the National Jamboree to offer the opportunity for youth to experience educational experiences close to nature, the opportunity to share experiences and dialogue, in addition to serving as an environment of friendship and integration, becoming a space to inform, raise awareness and commit participants to actions that help build a better world.

The fundamental principles that guide the National Scout Jamboree are:

- To secure, primarily, a **safe and inclusive space** for everybody, enabling self-development through positive and healthy interpersonal relations;
- Strengthen the **educational environment** in all aspects of the event, through the experience of the Scout Educational Method, in a space of mutual learning and shared responsibilities;
- Provide experiences that encourage the scouts to learn about the centenary history of the Scouts of Brazil, to reflect on the **values of Scouting** and its commitment to the future;
- Challenge to think differently, through the experience of transforming experiences;
- To provide an environment where **Sustainable Development** is valued, especially through the responsible use of resources, care for nature, promotion of a culture of peace and understanding, and work in favor of values and attitudes oriented towards coexistence.

4) Program

The Program of the National Jamboree is:

- **Ceremonies:** Including the opening, closing, and commemorative ceremonies of the Centenary of the Scouts of Brazil. These will be inspiring moments where participants can celebrate the Scout Fraternity, reinforce their values, and have fun.
- **Night activities:** activities carried out in the subcamps, such as the City Fair, Scout Night, and Folklore Festival. In addition to these, a special show will also be held to commemorate the Centenary of the Scouts of Brazil;



- **Special Activities:** including Pre-Jamboree Activities, Arrival Activities, Centennial Badge, and Vitalizing Activities for those free time moments;
- Brazil Sustainable Development Village: The activities offered by Aldeia Brasil will have as its main objective to allow scouts to explore the main challenges that the world faces, acquire skills to act in front of these issues in their own communities, giving special emphasis on the Challenges of Sustainable Development Goals established by the UN.
- **Peace Grove:** It will be a space specially designed for the participants to expand their relationship with their faith or belief, strengthen concepts of peace and understanding, as well as an environment where manifestations of inclusion and diversity are valued;
- **Scout Center:** Stands where each Scout Region can show a little of its culture, offer activities and expose good practices;
- Thermas dos Laranjais Module: A full day of activities at Thermas dos Laranjais Water Park, amidst its various pools, slides and artificial beach;
- Scout Adventure Module: Fun and adventure including ropes activities, obstacle courses, orienteering, and many others;
- **Brazilian Games Module:** typical Scout games and games from different regions of our country, in addition to other activities to energize the participants;
- **Scout activities Module:** activities that value typically Scout techniques, such as knots and ties, bonfires, tracking, orientation, building pioneers, and shelters, among others.

More details on the activities program will be presented in future bulletins.

5) Camp Structure and Organization

- Responsibility, Coordination, and Organization of the event: The responsibility for holding the event lies with the Scouts of Brazil. The guidelines are defined by the Organizing Committee, composed of elected members of the National Executive Board and a representative of the Regional Board of UEB/SP and UEB/MG. The National Office EN, will be responsible for running the event, with the support of professionals and volunteers, as decided by the Organizing Committee.
- Field Opening, Field Reception, and Closing: The field will be open from 2 pm on July 13 (Saturday) and entry must follow the procedures that will be made available in the next bulletins. The field must be completely vacated by 12:00 on Saturday, July 20th (Saturday).



- Villages and Subcamps: The field will be divided into 2 Villages, one of the Scout Branch and the other of the Adventures Branch. Each Village will consist of 4 subcamps, each containing up to 20 troops. Subcamps will be managed by teams composed of 4 members, of which one will be designated as Subcamp Chief.
- **Troops, patrols, and scout leaders:** Each troop will consist of 4 patrols, each with 9 young people and 1 scout leader who will accompany them, totaling 40 people. One of the Scouts will be designated as Troop Leader.
- Camping Area and Field Materials: Each troop will have an approximate area of 24 x 24 meters, where they will have to install the 4 patrols and the 4 scout leaders. In this space, each patrol should set up its own kitchen, where meals will be served (breakfast, lunch, and dinner). More information about the campsite, as well as patrol materials, will be made available in future bulletins.
- Scout Center: The Scout Center will be formed by the stands of the Scout Regions present, where cultural presentations will be developed, close to where the commercial area will be set up, with a Scout Shop, market, snack bar, ice cream shop, and others. More information will be released in future newsletters.
- Regional Contingent Coordinators: Each Regional Board must designate a regional person in charge, who will be responsible for passing on information from the Jamboree to the Scout Groups, organizing the assembly of patrols and troops, and other functions assigned to him. He will also be responsible for organizing his region's stand at the Scout Centre. The deadline for regional boards to nominate the Regional Coordinator is July 31, 2023.
- Shared responsibility: The National Jamboree is a space for learning and shared responsibility, which uses the Scout Educational Method as a reference, where self-education and the development of autonomy are valued. This means that our educational proposal must be present at all times during the Jamboree, both in activities and in the routines of the camp. In this way, participants are also responsible for the proper use, cleaning, and maintenance of common areas (subcamps, bathrooms, kitchens, etc.) and must be guided by Scouts to collaborate in these processes, as part of their educational experience and life in the subcamp.

6) Food at the National Jamboree As informações deste item passaram por alterações no boletim 2.

a) Feeding the Troops (Scouts and Scouts leaders)

Food is not included in the Jamboree registration fee and must be provided by each patrol.

- The patrol may choose to take food from its origin, and/or purchase food at the field market.
- The organization of the National Jamboree will install a market inside the field, offering perishable and non-perishable food, within a line that allows the preparation of food with quality standards. The list of products and prices sold on the market will be published in the next bulletin.
- The scout leaders, who will be accompanying the scouts, will have their meals with the patrols.
- More information on troop feeding will be given in upcoming bulletins.

b) Food for the Staff



Staff will have their food included in the Jamboree fee and will be served in a specific restaurant.

7) Patrol Equipment

In the next bulletins, the necessary materials that each patrol should take will be informed. The organization of the event will provide for each troop:

- Two-burner stove (1 for each patrol);
- Gas cylinder (already with valves, hoses, and installations);
- Table to support 4 stoves.

8) Staff Camp

Staff will camp in a specific location, with exclusive access, and must show up with their respective tents for this purpose.

9) Health and Safety

a) Medical care

The Jamboree's organization will maintain a first aid team in the places where it is necessary and its own medical staff, in the camp area, for emergency care. Cases that require another type of care will be referred to the hospital network. Participants affiliated with health plans or with health insurance must bring their credentials.

b) Safety

The external security of the camping area will be the responsibility of a contracted company, and the internal security will be the mission of the security team made up of members of the Service Team, whose main responsibility will be to ensure compliance with the rules of the event, to which they must be fully committed cooperation. Its members will be duly identified.

10) Participation

The activity is aimed at members of the Scouts of Brazil - who are linked to a Local Scout Unit and who are active in the Scout Movement, with mandatory Institutional Registration in force on the date of the event.

a) Youth

Participation in the event as a "youth" is possible for those born between 07/13/2013 and 07/20/2006 (must have turned at least 11 years old by July 13, 2024, and cannot have turned 18 before July 19, 2024). Patrols, troops, and subcamps will be formed by Branch - Scout or Senior.

b) Scout Leader



Participation in the Jamboree as a "scout" (responsible for a patrol with 9 youths) is allowed for adults who follow the requirements:

- Are aged 18 or over on the date the camp begins;
- Possess, preferably, experience in leading Troops from the Scout or Senior Branches;

Enrollment as a "Scout" is conditioned to the existence of enrollments of young people in your Group/District, to form a patrol with nine young people, for which you will be designated as responsible.

IMPORTANT: Effective participation in the "Scout leader" category is conditioned to filling the 9 vacancies of a patrol. If the 9 vacancies are not completed, and there is a need to join members of other Local Scout Units, preference will be given to the Scout who has the largest number of young people from his Scout Group in the patrol.

c) Staff As informações deste item passaram por alterações no boletim 2.

Participation as a member of the "Service Team" is possible for adults who meet the following requirements:

- Are aged 18 or over on the date the camp begins;
- Possess the certificate of completion of the "Training Course for Service Team Safe Space and Operations", which will be made available by the Event Organization on an EAD platform.

Participation as a member of the "Service Team" is subject to the needs of the event and the profile established for the role. It may be previously defined, or not, which will be the sector of performance of the staff member in the event, according to the needs of the coordination.

The tasks and functions of the Service Team will be defined by the organizers of the National Scout Jamboree in a specific newsletter.

IMPORTANT: Members of the Service Team must arrive at the field on 07/12/24 (Friday), by 12:00 noon to receive specific training on their role. This condition is mandatory and must be observed by the adult at the time of application.

11) Registration

SENDING THE APPLICATION FORM

The procedure of sending the application form will be informed in the next bulletin.

IMPORTANT: The deadline for sending the Registration Form, containing all signatures, is 06/05/2024.

a) Enrollment of Associates from another WOSM Scout Association other institutional partners in the event

The administrative structure of the partner Association must authorize the registration of participants, attesting to the regularity of the interested party with their association for the year 2024.

- Enrollment must be made with the Events Sector of the Scouts of Brazil, through the email eventosal escoteiros.org.br and later access will be made available to fill in the individual form.
- In order to make up for the lack of registration with the União dos Escoteiros do Brasil UEB and to meet
 the administrative costs and insurance coverage for the event, it is defined that the Jamboree Fee for
 members of other WOSM Scout Association will be increased by R\$ 150.00 (one hundred and fifty reais
 referring to the Institutional Registration fee) and this value must be added to the first installment to be
 paid in accordance with item C below.

b) Jamboree Fee

Applications can be made on form from October 1, 2023;

The registration fee is intended to cover the following costs and expenses:

- Activities in general, including program tours and transfers;
- Trousseau consisting of an event badge, an activity handkerchief, a hat or cap, a badge, and a participant manual:
- Medical care in case of illness (excluding pre-existing illnesses) or accidents resulting from the event;
- Applications must be grouped into lots. Individual applications for participants or IST will not be accepted.
- Operating expenses, such as the creation and manufacture of promotional materials; postage costs sending documents and other correspondence to the Regions, Groups, and Scouts of Brazil members,
 with a view to participating in the Jamboree; telephone expenses; bank fees and costs related to the
 collection of bank slips; office supplies needed by the organization; travel and stays for the organization
 and promotion of the Jamboree; freight to transport the trousseau of the participants; acquisition of
 medication for use by the medical team; execution of works, constructions, and rental of structures
 necessary for the event; equipment rentals; rental of campsites and activities; etc.
- After confirmation is issued on the approved numbers, the respective "Proforma Invoice" will be issued. Payment transfer to the beneficiary bank in Brazil will only be authorized after the invoice is issued.
- The bank fees (currency exchange fee) from the internal (originating country) to the destination country (Brazil) must be for the account of the originating National Scout Organization.
- Registrations will only be considered confirmed after the bank credit is received in the event's current account (União dos Escoteiros do Brasil).

c) Replacement of Subscribers

The participant will be able to transfer his registration, without any prejudice, until 05/20/2024, through a specific form, with the consent of the two interested parties, as long as both are registered and the installments are up to date.

d) Service Team Incentive



As a way of encouraging the work performed by participants in the "Service Team", the Jamboree organization will refund up to 15% (fifteen percent) of the amount received as a Jamboree Fee, depending on the performance evaluation within the defined role, carried out by the event coordinator.

12) Troops and Patrols composition

Regional Coordinators must present the composition of patrols and troops by 06/05/2024. The Events Sector will keep the necessary information available to the Regional Coordinators in order to facilitate their work, in addition to those that will already be available at PAXTU.

13) Transport

Considering the existence of several options for commuting to the Jamboree:

- The organization of the event will not indicate an "official" Travel Agency;
- It will be up to the participant, alone or together with others, to define the best means and form of transportation to the Jamboree;
- The organization of the event will be able to commercialize with Tourism Agencies' spaces on the site
 www.escoteiros.org.br, without this characterizing a recommendation for use or a certificate of quality
 and suitability of the disclosed companies;
- The organization of the event will not provide any transfer to the Jamboree location.

14) Image rights

Participants in the event grant the Scouts of Brazil the right to use images, in the form of photographs or footage taken during the event, for the purpose of promoting Scouting in Brazil. As a result, UEB now has the right to use these images in graphic and digital materials in its productions, whether material intended for the Scouts themselves, or promotional material aimed at publicizing the Scout Movement.

15) Travel/Health Insurance

Every participant must take out, at his own expense, personal accident and health insurance covering the period between his departure and return to his home of origin if he wishes to cover more than that available in the Scout insurance, provided to all UEB members.

16) Unforeseen procedures

The Organizing Committee of the 9th National Scout Jamboree will decide on procedures not provided for in this document or any exceptionality.
